COMMENTS FROM THE PRESIDENT

Call to order in the telephone/internet meeting mode.

Santa's visit to the park made us all feel like kids again!

Occupancy in the park amounts to 122 of the 324 units, or about 1/3rd of capacity. 15 units of that amount are rentals.

SECRETARY'S REPORT – Steve Harvey

Approval of the minutes of the December 1st Open Board meeting was proposed, seconded by June, and passed

TREASURER'S REPORT – Marilyn Kopernick

Financial results nine months fiscal year to date continue better than budget, by \$41,000 through December. The major savings have been in the maintenance supervisory position as well as with two injured employees. Administration has been above budget because of insurance cost increases and the hiring of one contract guard for a month in the summer. Utilities were below forecast as a result of lower attendance in the park, while repair and maintenance costs were higher.

MOTION 1

I move that the board accept the March to November 2020 Financial Statements received from DRM and approved by the Financial Review Subcommittee. Second Barry and passed.

MOTION 2

There are \$3K in delinquent accounts- only two small old accounts are uncollectable so should be written off. Carolyn made one last effort but

they are two years old and there is no contact information for the prior owners.

I move that we write off two accounts receivables that in spite of efforts are uncollectible: Account 00104-2313 \$315 and Account 00104-0140 \$273. Second Steve and passed.

MOTION 3

We also have an accounts receivable for \$210 in account 1525 for RV Space Rental that is very old and in spite of efforts is uncollectible.

I move that we write off the accounts receivable amount in account 1525 for RV Space Rental \$210. Second Dave and passed.

MOTION 4

Fund Transfer Requirements: Resolution to Pre-Approve recurring expenses and transfer of Reserve Fund HOA component

As you may remember from last year, California Civil Code requires that the board approve all larger transfers from the reserve or operating accounts. To avoid having to approve each expenditure each month, we are permitted to approve monthly recurring obligations that may sometimes exceed the limit. The written resolution lists the ongoing utility and insurance payments from the operating account that may exceed the limit but it is too lengthy to read out so:

I move that the board approve the resolution (detail attached below) to authorize the Transfer of funds from the Association's Operating account to pay for monthly recurring obligations including transfers to the reserve fund. Second Steve and passed

Architecture – Steve Harvey

Barb Eggiman attended the meeting and indicated that the park is looking good when considering the number of members absent. The committee is meeting on the 2nd and 4th Tuesdays of the month. It invites those interested in joining the committee to attend. Eleven work orders were approved in December.

Buildings and Grounds – Dave Haines

Dave presented two ER's; A contract of \$3550 for pond cleaning, and one to replace the main pool filter at a cost of \$611.66. Both second by Barry and approved. Pond cleaning has begun and will run throughout the week on both the A and B side.

Emergency Preparedness - Barry Rutz

Discussion has been initiated regarding acquiring a portable trailer for use in an emergency, timing deferred to the in the2021-2022 season. Residents should think of having a stockpile of emergency supplies – TP, water, granola, canned goods. Look in the red book.

Landscaping and Design – Cheryl Boyer

ER for \$1920 presented for Kirkpatrick to replace plants in February, second by Marilyn, passed.

A message from Nancy Clarke thanking all homeowners, the in-house landscape crew, and Kirkpatrick for their work on ponds and irrigation. The boulevard project has been completed with coordinated gravel, edging and stones and improves the appearance of the entrance.

Real Estate – Brian Dolsen

No report. Mark Monaco has one renter for Jan & Feb. He has done some showings.

Security – Barry Rutz

An ER for \$6175 was presented to install spikes on 112 feet on the north wall and improve the gate there, Dave second and passed. Consideration is being given to exit control on the main gate and to installing more security on the east wall. Improved positioning of sensor cameras has reduced the incidents of false alarms.

Nominees are Barb Eggiman and Ken Bailey, returning members Cheryl Boyer and Dave Haines. Gerry Page, speaking for Stan Miller, said that the recruiting process went more smoothly than in the recent past.

Lots of kudos to the owners in the park who have always been ready for the inspections by having their lot looking clean and tidy. Many lots are so well maintained that the committee has never had to contact them for any reason. There were other articles that talked about the concerns we all had to address when California was in a Discussion was centered severe drought. around the need to have less grass and more desert landscape. Additionally, the Indio Water District was here checking to see that irrigation water was not over spraying onto hard surfaces. It was during that time we changed some landscape areas to desert scape especially if it abutted the street or sidewalk. Several times the articles served as a reminder to maintain your lot for the entire season. We reminded everyone

that hedges and trees need trimming more than once a season and that weed control is constant.

In today's article I'd like to extend a "Welcome" to all the new lot owners. During the 2018--2020 seasons (pre-Covid) several lots changed hands. Our committee was busy answering questions and giving approvals to the many wonderful upgrades you were all making to your new digs. It is a real bonus that you made these changes that show improvements for your benefit as well as the entire park community. Your hard work shows up every time someone walks by your lot.

The AC team would like to thank all the owners, both in the park and those who were not able to travel down this year, for keeping their properties neat and tidy. It is a big task to conform to the rules of the park which makes our park the envy of all others in the valley.

BUILDING & GROUNDS COMMITTEE

Happy New Year to all. January activity by Building and Grounds has continued to be a busy time.

The new tractor has been wonderful. We are most grateful to have the reliability that our old one lacked.

The first week of January, Bio Clear Solutions worked on our ponds and canals. The majority of their work was on the pond adjacent to Lot 82. After draining, a huge amount of muck and mud was removed over two plus days - who realized it was that deep? While they had the pond drained, they unclogged the discharge pipe from the pump to the upper two ponds on the A side. In addition, they removed aquatic weeds growing in some of the canals and cleaned the bottom

and screen around the pond pump on the Eastern pond on B side. They have also provided a lot of good advice and information regarding the flow and aeration of the pond water to help abate the growth of algae and aquatic weeds.

The pool heater for the A side pool was beyond repair and was replaced by the B & G folks who were ably led by Matt Felix and Don Hammond. Don has wasted no time inserting himself into projects since his arrival.

The buried cable between the pedestals of site 127 and 128 failed. Our crew hand dug the trench between the two pedestals for the new cable and the electrical connections were made by D & L Electrical Co. Now is a good time for each owner to check their pedestal. Make sure that the pedestal does not have any dirt around the bottom. Also, try to wiggle the pedestal from the top. If it wiggles at all, it needs to be repaired or replaced. Each of us own the pedestal and any wiring to and including our units. Desert Aire is responsible for the wiring and electricity up to the connection at the pedestal.

We have also been working on obtaining bids for the refinishing of the clubhouse doors. Most of us have grown accustomed to closing our eyes and looking the other way as we walk down the passage way hoping that ignoring the problem will make it go away. B & G has made the decision to seek professional help on this project because the cumulative do it yourself approach has seriously eroded the appearance we expect for our clubhouse.

We also have been seeking bids for the refurbishing and general maintenance of the decking and coping areas of the three pools. The main pool project was deferred last year because of Covid. Waiting a year has further eroded the condition and appearance of all three pools.

You will notice a change in LOT 4 at the dumpster. We have made it so when you take your green waste to Lot 4, you can walk up the stairs adjacent to the dumpster and toss it into our dump trailer. Please snip and cut your waste into very small pieces as that will make the filling of the trailer more efficient. The same goes for any green waste you leave at the curb for Tuesday pickup, make sure it is snipped into very small pieces.

The two smaller dumpsters are for recycling only. You can see lists of what is acceptable on page 36 of our park directory. Please keep those lists in mind when placing your recycling at the curb each week. Please do not place garbage in your recycling container. When you are recycling cardboard boxes, please break the box down or crush. It makes it easier for our crew to transport to Lot 4 and doesn't fill the dumpsters with lots of vacant space created by a fully assembled box.

Counting of the ballots will be conducted on March 6 during the virtual Annual Meeting and the results will be reported accordingly.
