# Highlights of the Open Board Meetings INTRODUCTIONS – President Barry Rutz

Introduced the Board. Those present are Barb Eggiman, Cheryl Boyer, Dave Haines, Ken Bailey and Carolyn Quintana, office manager. June Cavendish is absent. Steve Harvey has not arrived at the park yet.

# **COMMENTS FROM THE PRESIDENT - Barry Rutz**

Stated that California has extended the mandatory indoor public spaces mask mandate until February 15, 2022. Covid positive persons may end their isolation in 5 days if symptoms are not present or with a negative test at day 5. If unable to test or choosing not to test and no symptoms are present or are resolving isolation can end after 10 days. With a positive test at

day 5 guidelines request you quarantine until day 10. Wear a well-fitting mask around others for a total of 10 days.

Shared that the activities committee is still looking for Chairman of the Chair Committee and a Chairman for Entertainment Coordination. Entertainers have already been lined up for 2023.

The next board meeting will be Tuesday, February 1, 2022, when candidates for the next Board will present their campaign statements.

Hot Topics session has been postponed until February 28, 2022.

Homeowners when you see problems outside or inside in common area grounds, contact Carolyn Quintana in the office. She notifies the grounds crew to correct the problem. Please do not flag down the workers.

Yard cleanup of individual lots needs to be completed by November 15<sup>th</sup> of each year but lots also needs to be maintained throughout the season until the first of April.

Speed limit for all vehicles, golf carts, electric bicycles is 15 MPH. Please adhere to this rule to keep everyone in the park safe and prevent accidents.

The Board has been tasked with reviewing a specific Bylaw regarding filling a new Board member slot when there are only equal numbers of candidates to open Board positions. This negates the necessity of a vote. The new Board candidates will be verified via acclimation. Written Notification of this potential Bylaw change will be put in owners' mailboxes within the week. A 28-day discussion period will be held before the process proceeds. This change will require a 66 2/3 owner yes vote to become effective. Note that this change does not preclude the Election Committee from pursuing as many qualified candidates as possible for each election.

SECRETARY'S REPORT – June Cavendish-Absent. Cheryl Boyer requested to take minutes. Cheryl moved to accept the minutes from the December 7, 2021, general meeting. Ken Bailey seconded the motion. Motion passed.

#### TREASURER'S REPORT – Barb Eggiman

Introductions: First I would like to thank the Finance Committee – Marilyn Kopernick, Bob Langin, Steve Such, Hope Hilliard and Anne King for the time they spend each month working on the finances here at DA. Every month, the details of income and expenses are reviewed.

# Financial report for the period: ending November 30, 2021:

**Operating Fund** – Operating YTD expenses have exceeded the budget by \$24K

### **Major Variances**

# Payroll & Benefits -- Favorable by \$3K.

- 1. Administrative no issues.
- 2. Utilities Electricity was \$4K over budget due to rate increases effecting cost each month.

  Gas was \$5K over budget. Water was slightly over budget.
- 3. Landscaping \$10K over budget. Mostly due to unexpected grass seed prices and overall cost to do business especially irrigation parts and services.

Note: Both 2020 & 2021 Financial statements reflect the impact the Covid Pandemic has had on the overall operations of the park. The 2022 Budget is expected to have taken these variations into consideration to produce a more accurate month to month budget report.

Barbara moved that the Board accept the November 2021 financial report received from DRM, as corrected by the finance committee and approved by the Financial Review Subcommittee. Seconded by Cheryl. Motion passed.

**MANAGEMENT REPORT** – Carolyn Quintana-No report

### **Buildings & Grounds – Dave Haines**

The water problem at the car wash and shop is being resolved. A permanent solution is in the works and he asks that homeowners avoid the boulevard by the carwash due to construction.

Work is nearly completed on repair of natural gas service to B Laundry and pool.

#### **BUILDING & GROUNDS COMMITTEE**

Bill Wilson, B & G Member

January has proved to be a very busy month for the B & G Crew. We completed two large projects that have significantly impacted all residents of Desert Aire. The gas leak that developed at the "B" side Pool and Laundry was not only significant, but dangerous. underground piping ruptured which supplied gas to the pool heater and hot water heaters for the restrooms and laundry. It then leaked a significant amount gas into the ground which needed to be removed prior to commencing work to replace the piping. Once the ground was declared safe, the B & G Crew removed concrete and exposed the pipe so that it could be repaired. Once repaired, our guys covered the pipe and repaired the cement.

As this goes to press, the B & G crew is putting the finishing touches on the project to reestablish water service to the shop and car wash stations. It has been a long running saga and we are most grateful for everyone's patience understanding. We had extended negotiations with the Indio Water Authority about creating access to their water main in the boulevard. proved too When their requirements burdensome and expensive, we switched to Plan B. Plan B was to hire a company to bore a route from the shop water system to the "B" side water main which was located at the rear of Lot 214. That allowed us to tap into our potable water system. The boring company was successful and the water lines have been hooked up so that the shop and car washing stations now have water service. Actually, plan B gave us a better solution to the problem and saved DA about \$7,000 on the project plus we don't have the forever added cost of a monthly bill plus fees and taxes. Forgive us for feeling a bit giddy about this because we had several local folks tell us it couldn't be done.

In the coming weeks, we will be working to

reposition the water main control valves at the Lot 214 site to a more surface position from the nearly five feet depth that they currently exist.

B & G folks have been working on the golf course to get bare spots reseeded and to kill weeds. Next, we will work on the sprinkler system to ensure complete coverage of the grass.

The failure of the pump that increases the water pressure of the canal water, which makes it possible for the sprinkler systems to operate, really degraded the system to water the common areas. Long term delivery of the necessary repair parts compounded the problem. We purchased a smaller pump to get some ability to deliver water. The pump has now been repaired and the sprinkler systems are fully operational.

Responsibility for the maintenance and organization of the wood shop has now passed to Brent Warne, Lot 36. You will notice his impact already with new equipment and repairs and adjustment of the existing equipment. He has some definite ideas about organization of the equipment. His mantra is safety, so everything he has done and is planning for the future is directed to safety and proper use of Talk to Brent if have thoughts equipment. concerning the wood shop. Please support Brent's efforts by cleaning up after using the equipment or informing him if a piece of equipment is not working properly.

Reminders for all of us to save on time and efficiency:

#### DON'T

- Don't remove tools from the Maintenance Shop for personal use – they often don't return
- Don't dispose of major appliances (water heaters, refrigerators, ranges, etc) at Lot 4 – when you purchase, make sure that the

vendor will pick up the old one.

 Please don't feed the wildlife – particularly the ducks. It is cute to have them dine with you. However, they don't discriminate where they leave their after dinner calling cards, creating surprises for other folks on their patios and decks and our maintenance people while working in the common areas.

#### DO

- Do Flatten all cardboard when recycling includes small packing boxes, cereal boxes, mail packaging
- 2. Do flatten chairs and other furniture you are recycling. If it is too good for that, then donate it to one of the resale charities most of them will even pick it up
- Do adjust your sprinklers and other watering methods so that you don't have water running into the street – if it is running into the street, you probably are watering too much. We have to pay for all water that goes through the meter, even it goes to the street.

#### LANDSCAPE & DESIGN COMMITTEE

Mother Nature recently dealt us some extremely cool weather & fortunately the frost did not destroy the flowers, throughout our Park.

The entrance to Lot Fore has been significantly enhanced. The "in-house" crew agreed to tackle the maintenance of this area, which was long overdue, and far too long ignored. This will now make it easier to maintain, in the long run. L&D gave them a plan, utilizing some materials we had & added some new plantings. We will continue to look at ways & means to improve the overall look and maintenance of this pitch 'n putt area.

L&D will focus on one project this season, that being the patio area. Our committee is

discussing ways to enhance & improve the raised garden around the patio. Many plants are beyond their "due date". The overall surface of this garden needs to be changed. Improved lighting will also be discussed, as will shade options. Improved irrigation & an overall "updated look" is in need. Working with the long-range planning committee is our focus, this year and project planning will evolve from this. The patio area is and will be used more & more, amidst our restrictions for socializing, with the ever-looming virus that forces us to meet outdoors.

In this climate there is an appropriate time for planting certain trees, shrubs & flowers. Likewise there is an appropriate technique & time of year for pruning trees & bushes. The winter months are not ideal for planting. Hence, Kirkpatrick scheduled extensive replacement of plants the end of January. They are the professionals, they follow a routine accordingly. In maintaining our desert scaped gardens, their experienced crew member follows a rotating monthly schedule. If you have any questions regarding irrigation, flowers, plants or trees, in the desertscaped areas, would you kindly send an email to Carolyn, in our office. If an issue is cause for concern, it will be dealt with immediately. If there is a problem, we need to put this in the hands of the professionals. We sincerely thank you for your respect in following this procedure.

The wall facing the parking area, by the entrance to the patio/pool area will be painted the same color as the community building. We want to monitor how the elements will treat this paint. Future enhancements of this wall are on hold.

Should you wish to clip a rose from the Park's gardens, there is a proper way of trimming. The correct way to cut a Rose is to go down from the bloom to the first outfacing five leaf branch and cut at an angle, just above that branch. Kirkpatrick Landscaping maintains our Rose gardens and would appreciate it if you would
