MINUTES DESERT AIRE OPEN BOARD MEETING DECEMBER 7, 2021

Highlights of the Open Board Meetings

INTRODUCTIONS – President Barry Rutz introduced the Board. Those present were June Cavendish, Barb Eggiman, Cheryl Boyer, Dave Haines, Ken Bailey and Carolyn Quintana, office manager. Steve Harvey has not arrived at the park yet.

COMMENTS FROM THE PRESIDENT -

Barry read two policy statements pertaining to electrical issues and replacement of gate cards. These two issues are not new. They have been verbal all these years and it was felt that they should be put in writing. Barb made a motion to accept these policies and June seconded. Motion passed. These policies will be posted on the main bulletin board for your review.

Reminders were made on quiet hours (10 pm to 8 am), recycle items and bins at lot 4 (please put items in proper bins, do not put tree limbs or grass in your garbage can. Put these items on curb for Tuesday pick up or take them to lot 4 and put them in the trailer.

Spectrum contract will be renewed in March. We were able to keep the cost about the same and more channels added. More information will be provided next month.

The laundry contract has not been changed since 2008. With the increase of water rates it was felt that we needed to increase the price. The rate will be increased by 25 cents per load effective January 1, 2022.

This year we have an overflow of second vehicles. Our rules state that you cannot park a vehicle on the street overnight. Because all the

assigned spots are taken the board has agreed to allow overnight parking in front of the office – 8:00 p.m. to 8:00 a.m. for this season.

SECRETARY'S REPORT – June Cavendish made a motion to accept the minutes from the November 2, 2021 general meeting. Dave seconded the motion. Motion passed.

TREASURERS REPORT – Barb Eggiman thanked the Finance committee for all their work in overseeing the finances of the park. The operating fund ending Oct. 31, 2021 has exceeded the budget by \$13K due to increases in utilities (gas and water) and landscaping (unexpected increase in grass seed). Barb made a motion that the Board accept the October 2021 financial report as received from DRM and approved by the finance committee. Cheryl seconded the motion. Motion passed. The reserve fund balance is \$622,737.00 which is an increase of \$15K.

The 2022 budget package was approved at the budget open board meeting on November 15th. The package was sent to homeowners on December 1. The board approved a \$20 increase in the monthly HOA assessment. The increase is to cover the overall cost to do business, utilities, cost of products, cost of living, landscape supplies, insurance. If you did not receive the annual budget report please contact Carolyn Quintana.

MANAGEMENT REPORT – Carolyn Quintana reminded everyone to pick up their mail and packages on a timely basis. With everyone ordering on line the mail room is becoming full of packages.

COMMITTEE REPORTS –

Activities – June Cavendish

June reported that there are two vacancies of committee heads that need to be filled. Jim Campbell has stepped down as the entertainment coordinator and Dan Malcolm has

stepped down as the coordinator for the chair committee. These are two very important committees that keep our park running. Please see Teddy Wilson or June Cavendish if you would like to volunteer for one of these committees.

The annual toy drive is underway and Judy Akins and Cec Conway are asking everyone to please contribute an unwrapped toy. These toys go to the rescue mission for children in need.

Buildings & Grounds – Dave Haines

Dave reported on the water problem at the car wash and shop area. IWA has finally signed off everything so work should begin soon. The following ER's were presented for approval:

 Water service (IWA) & Contractor - \$8,000.00

Dave made motion for acceptance of ER's for payment and it was seconded by Barb. Motion was passed.

Architectural – Steve Harvey

Elaine Babcock gave the report that the yearly lot inspections were complete and reminded everyone that your lot needs to stay in compliance until April 1. The architectural committee will be holding an informational meeting for new homeowners on Jan. 11th at 9 am on the patio to discuss the procedures for making changes to your lots.

Landscape & Design – Cheryl Boyer

Nancy Clarke gave the report for the committee. They will be working on issues around the lot 4 pitch & putt area, lighting in the park, patio

shade. If you would like to have a plaque in the memorial garden you can pick up a form in the office. If you have any gardening questions please feel free to stop in at Bob Williams Nursery on Madison. They will be glad to work with you. Pictures are being updated for the crew and will be posted in the mail room.

Emergency Preparedness – Cheryl Boyer

Mark Wilson is still working on putting together an emergency supply trailer.

Security – Barry Rutz

Gordie Klein reported that the summer was very calm, not many calls in the middle of the night. The heat did take a toll on some of the equipment. Thanked Del Lawton for his help on installing a new light on the security cart. The committee is looking into improvements to the front gate system. Gordie also reminded everyone to slow down, the speed limit is 15 MPH. If you are walking at night please take a flash light. Security is also asking everyone to leave a light on outside at night. It helps to keep the bad guy away.

Marketing & Communications – June Cavendish

Hope Hilliard reported that our web site is up and working. The site contains the monthly bulletin, listings of places for sale and rent by homeowners and through Mark Monoco. Face book is also working and feel free to add pictures to this site.

Nominating Committee – Ken Bailey

Stan Miller thanked his committee for their work on getting the candidates. He reported that 4 candidates have put their names up for the election in March. They are Calvin Cosens #161, Randy Miles #303, Kurt Neumann #232, Bruce Spalding #30. Their bios will appear in the next newsletter.

Real Estate – Ken Bailey

Mark Monoco did not have a report but he stated that there is a waiting list for rentals and very few for sale.

NEW BUSINESS - Barry read a list of 7 new homeowners during the month of November.

HOME OWNERS OPEN FORUM

Bob Adams #205 asked if the new contract with Spectrum will support a second TV. Barry said the little boxes that are currently in use will still be good. Bob also thanked Del and Keith Hunter for providing the free entertainment on the patio.

Stan Miller #11 asked about the water issue at the shop. The crew do not have water or restrooms to use at this time. Dave said that we have now been approved by IWA and hopefully work can get started quickly (As of 12/9/21 a temporary line has been run to the shop). Stan also thanked Barb for the annual budget report. Because of the high costs of utilities he asked if we could look at other areas for electrical use like solar and LED lighting outside.

Randy Miles #303 encouraged everyone to wear their name tags to functions because we have so many new homeowners. Carolyn has the information in the office to get the name tags.

Karen Such # 182 asked for articles and bios for the candidates to be turned into her by December 20.

Peggy Miller #11 asked for more Christmas gift items for teenagers for the Rescue Mission.

Catherine Chipuer #310 asked if the board had looked into wi-fi for homeowners instead of having the TV package. Barry said that a questionnaire was sent out to homeowners about a year ago and it showed that more homeowners wanted the TV service only instead

of adding the additional cost of wi-fi.

RoseAnn Stackhouse #167 does security and she was stating how important it is to light your lot at night. Also you need to make sure you leave a light on outside when you leave for the summer. It is pretty dark around the park during the summer when everyone is gone.

Welcome new lot owners. Sales have been brisk during 2020-2021. The Architectural Committee is hosting an informational meeting January 11, 2022, 9:00 am on the patio to give a brief overview of the purpose of the committee and the process and rules for lot owners. There will be time for questions. All are welcome to attend.

The first newsletter article of the New Year is a good time to remind all the owners of a few rules that are important to make the park looks its best at all times.

Rule 11 a: "Properties not properly maintained by November 15, will be maintained by the Grounds Superintendent at the owner's expense until the owner makes other arrangements. Landscaping must be maintained until April 1st whether the lot is occupied or not.

Rule 11-b-iii: "Shrubs, plants, etc. must be included in the proposed area, spaced a maximum of 48 inches apart and with an adequate water supply.

If you have contracted with a yard service, particularly if you are not in the park, please check with the service to confirm that your lot is being maintained per your agreement, including weed control.

Buildings and grounds would like to give a big THANK YOU to Matt Felix for all his work with

the pools and spa. The spa now has new depth markings. The spa water is now checked three times a day to keep the water chemistry in proper balance. We will also be changing the spa water at least monthly or as usage dictates. The spa area is now quieter without the air blower going. Matt has rejuvenated the built in air jets, utilizing 3D printing technology to make parts that are no longer available.

Training staff is also on going. Another big THANK YOU to RoseAnn Stackhouse for her willingness to do pool water testing. We recently had an annual inspection by Riverside County Health. Matt took the lead in taking care of the concerns they had.

Another round of THANKS to Judy Jinnings and Cathy Christie for scrubbing the main pool tile line clean. Sun screen, body oils, etc. make up the residue that builds up on the tile.

The main pool is brighter at night now because of new lights.

Moving on to ponds, all four collection ponds have now been cleaned plus the pond behind the club house. Our conversion to floating fountains continues as pumps fail.

We now have at least temporary water to the maintenance shop and car wash. Thanks to Stan Miller for pointing out the conditions and need for water there.

The Lot fore tables for recycle are now closed until after the New Year.

Just a reminder that lockable water valves are on display in the clubhouse walkway. Don't turn on water without checking all the outlets inside the house.
